Over 30 years later he's still going, working as Director of Education and Outreach for Missouri Organic

Recycling.

During his work at Missouri Organic, Stan has created the Food Too Good to Waste Science Unit which was purchased for all Kansas Schools in 2020 and has now reached over 10,000 Kansas Students with Composting and Food waste reduction lessons. 
